- COVID – 19 - Epidemic Disease Act, 1897 (Central Act 3 of 1897), Tamil Nadu Public Health Act 1939 Section.62 & 76 Regulation should adhered strictly by the institution.
- Display and exhibition board: As per Rule 3 of the Tamilnadu Prohibition and Smoking and Spitting Rules 2008.
- Every person incharge of place of public work or use shall display and exhibit a board at a conspicuous place in or outside the place prominently stating that the place is as "No smoking and No spitting Place" and that "Smoking or Spitting here is an offence" which shall be both in Tamil and English and the version in English shall be in the second place below the Tamil. Tamil Version shall be written predominantly in the board by Providing more space than English.
- No sale of Tobacco, No Smoking or Chewing of Tobacco inside the premises of institution (By the Students, Staff and Teachers)
- Display of sign boards (No smoking Area - Smoking Here is an Offence) of at least 60x30cm size inside the institution at various locations.
- No sale of Tobacco within the radius of 100 meters of the educational institution.(Head Master / Principal shall ensure)
- IBC materials like Posters that give information about the ill effects of Tobacco have to be displayed inside the institution and the institution should have a copy of COTPA 2003 and Rules 2008.
- Display of Sign Boards on sale of tobacco produce around the institution within 100 yards banned.
- Building approval should be obtained from Local Body / DTCP, Chennai.

This Certificate is liable to be cancelled at any time on infringement if any of the above conditions and for improper maintenance of sanitation & building and, if any, health Nuisance is found as defined in Section 3 of the Tamilnadu Public Health Act, 1939.

A sample of water stated to have been collected on 13.8.2018 from the R.O. plant outlet water in K.G. Block at Maharishi Vidyamandir Senior Secondary School, Chinnavedampatti, Coimbatore (Source : Corporation water) was received at this laboratory on the same day from the above premises to assess its suitability for drinking purpose.

The results of analysis are furnished herewith.

The sample of water is colourless and clear in physical appearance.

The chemical analysis reveals that, it is soft and mineralized. The total hardness content is 24 mg/l. It is of satisfactory chemical and bacteriological quality for drinking purpose.

However, it is advised that, the total hardness content should be maintained at 30 mg/l as the Calcium and Magnesium content are essential for healthy life of human being.
